REPRESENTATIVE MATTERS

Fatal accident between ambulance and motorcyclist due to alleged negligent vehicle operation, training, supervision and entrustment of vehicle to driver by ambulance company; 28 year-old father of 3 year-old and pregnant wife; \$15 million demand; negotiated settlement for \$5 million after extensive investigation, discovery and expert review (Delaware County Court of Common Pleas)

Premises liability case in which off-duty police officer fell into a trash pit at a public trash transfer station; plaintiff sustained fractured cervical and thoracic vertebrae and a torn rotator cuff requiring multiple surgeries and rendering him unable to return to law enforcement work; \$2.5 million demand; settled case at mediation for \$850,000 (Philadelphia County Court of Common Pleas)

Medical malpractice case involving alleged failure to diagnose cancer during gynecological office visit; \$3 million demand; obtained defense verdict for Ob/Gyn at trial (Lackawanna County Court of Common Pleas)

Breach of contract, unjust enrichment and fraud action brought by large healthcare network claiming failure of city and its prison medical vendor to make certain contractual payments for medical care of pre-trial detainees; \$1.5 million demand; negotiated pre-trial settlement of all claims for \$675,000 without contribution by the prison medical vendor (Philadelphia County Court of Common Pleas)

Products liability case against a national manufacturer of physical therapy equipment; plaintiff sustained burns to arm during therapy due to alleged product defect and negligence of therapist; obtained defense verdict for product manufacturer at arbitration (Delaware County Court of Common Pleas)

Commercial trucking accident in which trash truck crossed center line causing head on collision due to alleged negligent operation of the truck and negligent hiring and entrustment of the vehicle to driver by trash company; 23 year-old plaintiff sustained fractured pelvis, hip and internal organ injuries with two hip replacement surgeries; \$10 million demand and claim for punitive damages; settled case at early mediation for \$2.2 million (Monroe County Court of Common Pleas)

Commercial trucking accident in which tractor trailer over turned in a landfill due to alleged negligence in maintenance of landfill access roads; plaintiff driver sustained rotator cuff injury with surgical repair; \$650,000 demand; negotiated pre-trial settlement of case for \$15,000 after discovery and trial submissions filed (Philadelphia County Court of Common Pleas)

Commercial trucking incident in which trash truck allegedly forced passenger vehicle off of roadway into a tree; plaintiff sustained a fractured pelvis and hip; \$250,000 demand; case settled for \$35,000 on eve of trial (Bucks County Court of Common Pleas)

Commercial trucking accident in which roll off truck collided with a pick-up truck at a construction site due to alleged motor vehicle negligence of the roll off driver and improper construction site safety; plaintiff suffered multi-level lumbar disc injuries, a fractured elbow and bilateral carpal tunnel syndrome; \$1 million demand; negotiated joint tortfeasor settlement for roll off driver for \$135,000 on eve of trial; settled defendant then found to be 54% responsible for \$500,000 trial verdict (Philadelphia County Court of Common Pleas)

Premises liability case in which custodian at a mall tripped near a commercial trash compactor due to alleged defects in the compactor and the concrete pad on which it was placed; plaintiff suffered a traumatic brain injury, fractured nose and hip and an inguinal hernia; \$2 million demand; obtained the voluntary dismissal of the compactor vendor prior to trial after extensive investigation, discovery and expert review (Philadelphia County Court of Common Pleas)

Premises liability case at a funeral in which a visitor fell down a staircase at the cemetery office due to alleged defects in the stair case; plaintiff sustained a fractured nose and foot, facial lacerations and cervical sprain and strain; \$150,000 demand; negotiated pre-trial settlement of case for \$69,000 (Philadelphia County Court of Common Pleas)

Premises liability action in which trash tipper in landfill tipped over onto truck due to alleged negligent operation of the machine; plaintiff sustained multiple cervical herniations; \$350,000 demand; negotiated global settlement without contribution from landfill equipment operator and received indemnification of costs from other party (Bucks County Court of Common Pleas)

Premises liability action in which trash hauler fell off trailer while untarping it at landfill due to alleged negligence in not providing proper facilities to safely tarp; plaintiff suffered cervical disc injury at C5-C6, cervical radiculopathy, shoulder girdle injury, brachial plexus injury and carpal tunnel syndrome; \$750,000 demand; settled case at mediation for \$315,000 (Philadelphia County Court of Common Pleas)

Medical malpractice/hospital liability case involving post-surgical fall from hospital bed with resultant fractured hip; \$100,000 demand; obtained defense verdict for hospital at private, binding arbitration (Montgomery County Court of Common Pleas)

Medical malpractice case involving shoulder dystocia with permanent nerve damage due to alleged negligent pre-natal monitoring and delivery; \$200,000 demand; settled case on eve for trial for \$75,000 (Clinton County Court of Common Pleas)

Medical malpractice case involving complicated c-section delivery with resultant bilateral brachial plexus stretch injury, bilateral phrenic nerve injury, respiratory insufficiency, diaphragmatic paralysis, brain injury and spinal cord injury with subsequent failure to thrive and death at 3 years of age; \$2 million demand; negotiated global settlement of case after extensive investigation, discovery and expert review for \$775,000 (Lackawanna County Court of Common Pleas)

Civil rights and medical malpractice action involving incarcerated Plaintiff who contracted MRSA in prison with subsequent life-threatening complications due to alleged failure to timely diagnose and treat condition; \$100,000 demand; obtained voluntary dismissal of entire action after discovery and filing of Motion for Summary Judgment (U.S. District Court for Western District of Pennsylvania)

Civil rights and medical malpractice action involving prisoner who committed suicide while detained in city jail due to alleged negligent mental health screening and procedures on intake; \$250,000 demand; obtained voluntary pre-trial dismissal of prison medical vendor after extensive investigation, discovery and expert review (U.S. District Court for Eastern District of Pennsylvania)

Civil rights and medical malpractice action involving prisoner in city jail who died of heat stroke due to alleged negligent medical screenings and prison conditions; \$550,000 demand; negotiated global pre-trial settlement of case for \$125,000 (U.S. District Court for Eastern District of Pennsylvania)

Breach of contract and discrimination action brought by student who was discharged from nursing school six weeks prior to graduation; plaintiff alleged breach of education contract and discrimination against a protected class; \$154,000 demand; negotiated \$5,000 settlement of case and dismissal of PA Human Relations Commission charge after detailed investigation and preliminary discovery conferences with opposing counsel (Chester County Court of Common Pleas)

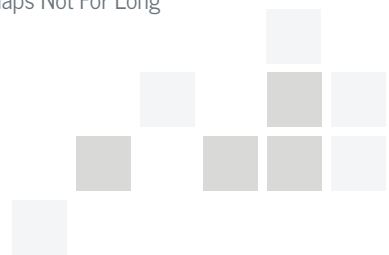
